Each apartment in this twenty-three floor elevator building has central air conditioning and heating. Each apartment kitchen is equipped with a refrigerator, gas stove, oven, microwave, and dishwasher. Each apartment has a washer and dryer in-unit. Apartments are unfurnished. There is 24-hour staffing in the lobby. Building amenities include a recreational lounge, conference room, fitness center, laundry room, and rooftop.

Tenants using moving companies are required to provide certificates of insurance (COI), emailed in advance of moving in, to Property.Management@nyulangone.org. Please reach out to Property Management for additional information regarding move in procedures, including elevator reservations. Elevator reservations must be made in advance of moves.

One pet per apartment is permitted, under 50lbs; pet type subject to approval.
Smoking, including e-cigarettes, is not permitted in or around NYU Langone facilities, including its residences.

Please do not send packages, furniture or other deliveries in advance of your arrival because these cannot be accepted or stored.

Please note that keys, mail and package services are provided only to tenants and family members authorized by NYU Langone Housing Services, as reflected on the building roster. Please be prepared to show photo I.D. as requested.

Utilities: Occupants pay for their own electricity (one account per apartment), telephone, high-speed internet, and cable television. While there is a central heating and air conditioning system in the building, electricity is used to run the heating-air conditioning unit(s) in each apartment. Water and cooking gas are provided.

You must contact Con Edison at 1-800-75-CONED to set up your apartment's account for electricity service to ensure that the service is not discontinued. Con Edison will need the following information: your telephone number; the address of your apartment; your date of occupancy; your social security number, resident alien number, passport ID number, or state license ID number.
